Important Information

- State Law requires that all dogs and cats over the age of 3 months are registered.
- A dog or cat must be microchipped and **proof of microchipping supplied** prior to the registration being accepted (except where exempt by legislation)
- Animals owned by people under 18 must be registered in the name of a parent or guardian.
- Your registration fee includes a State Government levy that is used to fund responsible pet ownership programs.

The personal information will be used solely by Council for that primary purpose or directly related purposes. The applicant understands that the personal information provided is for the use of Animal Services and that they may apply to Council for access and/or amendment of the information.
